Formula 1 Grand Prix 2026 Experience — Additional Prize Conditions

These clauses form part of the Prize Conditions (Section 12 of the Promotion Details and General Terms & Conditions) and apply specifically to the Formula 1 Grand Prix Experience Prize (Total Value \$30,000 AUD). Where inconsistent, these clauses prevail.

1. Acceptance / Decline of Prize / Alternate Formula 1 Package

- 1.1 The Winner must confirm acceptance of the Prize in writing within 14 days of notification (the "Acceptance Period").
- 1.2 If the Winner does not accept the Prize within the Acceptance Period or cannot attend the Monaco 2026 Grand Prix, the Promoter may, at its sole discretion, withdraw the Prize and instead offer an alternate Formula 1 Grand Prix experience in 2026 or 2027 at another location (e.g. Singapore, Budapest, Dubai, Austin or similar).
- 1.3 Any alternate Formula 1 package offered will:
- Reflect the actual cost of arrangements already made or committed by the Promoter;
- Not exceed AUD 30,000 in total value; and
- Include comparable inclusions where practicable (e.g. flights, accommodation for two people, event passes, spending money), but the duration or components may differ.
- 1.4 If the alternate Formula 1 package represents a lower-cost event, its total value and spending money may be reduced accordingly to reflect that destination.
- 1.5 Because airfares, accommodation and tickets for the Monaco 2026 event may already be purchased or contracted, the Promoter may deduct or apply those costs when substituting the alternate Prize.
- 1.6 No cash alternative is available unless the Promoter elects otherwise, and any cash option (if offered) will be of lesser value than the advertised Prize.
- 1.7 Alternate or substitute Prizes will be confirmed only after the Promoter cancels or modifies any existing bookings. Processing and confirmation of the alternate package may require several weeks.
- 1.8 If the Winner declines both the Monaco Prize and any alternate Formula 1 event offered, the Prize will be forfeited in full, and the Promoter will have no further liability or obligation.
- 1.9 For clarity, any alternate Formula 1 package offered under this Clause will only be scheduled for a future event in 2026 or 2027, as determined by the Promoter. The Promoter is not obliged to offer or deliver an alternate package scheduled earlier than Monaco 2026, nor to incur any costs prior to that event period.

2. Transferability

- 2.1 The Prize is transferable to another individual ("Nominee") nominated by the Winner, provided written notice is given within the Prize Claim Period.
- 2.2 The Nominee must satisfy all eligibility requirements (including being 18 years of age or older and an Australian resident).
- 2.3 If the Nominee is a minor, they must be accompanied by a parent or legal guardian for the entire duration of the Prize.

3. Changes to Itinerary / Availability / Costs

- 3.1 Accommodation is provided in Nice, France, with daily train transfers (approximately 20 minutes each way) to the Monaco Circuit. The Winner does not stay in Monaco.
- 3.2 Grandstand tickets are subject to availability. If unavailable, the Promoter will use best endeavours to secure alternative tickets of comparable spectator value.
- 3.3 The Promoter reserves the right to alter flights, accommodation, transport routes or event schedules where necessary for operational or cost reasons.
- 3.4 If costs increase (e.g. airfares, exchange rates, event ticket prices), the Promoter may reduce the scope or components of the Prize to remain within the AUD 30,000 cap.
- 3.5 The Promoter is not liable for any difference between the advertised value and actual cost incurred to deliver the Prize.

4. Force Majeure & Liability

- 4.1 The Promoter is not responsible for delays, cancellations or alterations caused by events beyond its control including but not limited to natural disasters, pandemics, strikes, supplier failure or flight disruption.
- 4.2 Except where liability cannot be excluded by law, the Promoter and its agents disclaim all liability for loss, injury or damage arising from participation in the Promotion or acceptance of the Prize.
- 4.3 The Winner and/or Nominee are responsible for holding valid passports, visas and meeting any vaccination or entry requirements at their own cost.

5. Publicity / Use of Winner's Image

The Winner agrees to participate in reasonable promotional activity arranged by the Promoter and consents to their name, likeness and image being used for marketing and media purposes without further payment or approval.

6. Privacy / Personal Information

Personal information collected is handled in accordance with the Promoter's Privacy Policy (as published on www.unlckd.com) and used for administration of the Promotion and marketing communications.

7. Amendment / Cancellation / Jurisdiction

- 7.1 The Promoter may amend, suspend or cancel these Prize Conditions or the Prize for any reason beyond its control, with notice published at www.unlckd.com/monacoF1.
- 7.2 All disputes arising from these Terms & Conditions shall be governed by the laws of Victoria, Australia, and subject to the exclusive jurisdiction of the Victorian Courts.
- 7.3 The Promoter reserves the right to revise, substitute or withdraw any alternate Formula 1 package or related inclusions at its sole discretion to reflect ticket availability, cost changes, or operational constraints.
